

REACH (Registration, Evaluation, Authorisation, and Restriction of Chemicals) Statement Policy

1. Purpose

This REACH Statement Policy outlines the commitment of European Thermodynamic Limited to comply with the European Union Regulation (EC) No 1907/2006 concerning the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH). The objective is to ensure the responsible and safe use of chemicals throughout their life cycle, promoting human health, environmental protection, and innovation.

2. Scope

This policy applies to all employees, contractors, and suppliers of European Thermodynamic Limited involved in manufacturing, importing, distributing, and using chemical substances and mixtures subject to REACH regulations.

- c. **Authorisation:** Seeking authorisation for substances listed in Annex XIV and ensuring the safe use of such substances within the scope of granted authorisations.
- d. **Restriction:** Complying with restrictions on manufacturing, placing on the market, or using certain hazardous substances.

4. Communication and Information Exchange

European Thermodynamic Limited is committed to transparent communication regarding chemical safety and providing relevant information to downstream users, customers, and other stakeholders. This includes:

- a. Communicating information on safe use to downstream users in the supply chain.
- b. Sharing relevant safety data sheets (SDS) with customers and ensuring that SDS are up-to-date and accessible.
- c. Collaborating with suppliers to obtain necessary information on the safe use of substances.
